Synopsis of Board Meeting

April 21, 2020 WebEx Virtual Meeting

CALL TO ORDER at 7:02 p.m.

COMMITTEE REPORTS – Mr. McCurdy updated the Board on the following:

Long-Range Facilities Planning Committee Update:

Centerville Library Parking Lot Replacement Project. The Library received 4 bids. One bid was significantly lower than the others. LWC conducted a post bid interview with the lowest bidder and followed up by contacted the companies references. The lowest bidder is Outdoor Enterprises (OE). OE said they bid aggressively because they had a gap in their schedule they wanted to fill and wanted to be the successful bidder. Discussion was held about the issue with bad soil. The soil is not bad throughout thinking is about a third is bad mostly towards the south end but will know once they remove all the old asphalt and material. OE has a \$17,000 allowance for soil stabilization.

Mr. McCurdy went on to say that OE quoted two alternatives for phases. If WCPL chooses to do the project in 1 phase instead of the original plan of 2 phases, OE would be able to mobilize the end of April. Two phases could take up to about 16 weeks and one phase would be about 8 to 10 weeks. Mr. Carr interjected that though he will abstain from voting, he found the 1 phase and the ability for OE to begin in April is very attractive and would be wonderful for patrons to come back to a new parking lot once we are able to open. Mr. Nunna agreed that we should take advantage of the library being closed to complete this project.

Mr. McCurdy stated the original estimate was \$614,000 for the entire project. OE had a base bid of \$553,854. They have a \$17,000 allowance for soils stabilization and \$13,500 allowance for site furnishings. Using 1 phase would save \$5000, eliminating new plantings at north end of the property would save \$15,000 and eliminating extending existing irrigation would save \$12,000. Mr. McCurdy stated that LWC recommends work begin at the south end of the property to help determine the extent of the bad soil and if it will cost more than anticipated to stabilize.

The Board approved a motion to accept Outdoor Enterprise's bid, as noted by LWC, to complete in 1 phase at \$548,854 with \$17,000 bad soil allowance and \$13,500 site furnishing allowance to begin as soon as stated by Outdoor Enterprise. All in Favor, six members. Opposed, None. Abstain, one member.
